### **MATTERS ARISING**

DEFIBRILLATOR. The application for a Grant of £1000 from D.C. Passmore had been successful. Two quotes had been obtained and the Clerk was waiting for a third. The VHMC was happy for this project to go ahead. Clerk to also enquire if any ongoing maintenance would be required.
